I heard from our Flock representative this week. They are currently running a special that will waive all installation costs. This would be a savings of \$5,800 for us. The requirement is that we need to sign the attached

agreement with them by May 31<sup>st</sup>. I have money in the FY26 budget for this project, and it will not be billed nor installed until July.
